1. The meeting was called to order. Introductions were made.

3. Public Comments to the Transition Planning Committee

No comments made.

4. Correspondence

- Representatives from Clark and Lincoln County have contacted Jim Canales expressing interest in CCCW.
- Jim Canales shared a February 15 memo from Secretary Hayden regarding Family Care Expansion during the 07-09 Biennium. In this correspondence, Secretary Hayden expresses a commitment to Family Care expansion and states that although the Governor's budget did not include a multi-year commitment to the 22% Community Aids buy down, there is flexibility in the Family Care budget.
- Vicki Tylka, Jim Canales, and Dave Bast received phone calls from Kathleen Luedke, Judith Frye, and Sinikka Santala to follow up with concerns the budget proposal may have caused. They have asked Vicki to make statement on Friday, February 16, that specifically outlines county needs that will have to be addressed if CCCW is to move forward. Vicki explained that in addition to the 22% Community Aids, the counties will need to evaluate Economic Support needs. Wood County's primary concern at this time is the 24 month phase in of those on waiting lists, as it exceeds their current waiting period for consumers. It was agreed that the Economic Support calculations will be sought immediately and that this group will begin the legislative process to gain support of Central Wisconsin Legislators and Representatives. Kate Norby will continue to plan for a meeting with Legislators in early March.

5. Project Coordinator's Report

- The website development is in progress. Kate Norby will be reviewing the final four designs on Wednesday, February 21.
- Kate Norby participated in the February 1st Consumer Corp Training in Wisconsin Rapids. It was made clear that consumers and other stakeholders would like more information about the planning activities in this region. Consumers did not make up the majority of those in attendance.
- Planning for a Legislators meeting is underway. Kate will keep the Committee informed of specific information as it becomes available.
